Abstract

Ms. Hancock will discuss several potential regulatory reforms to limit future financial crises, including augmenting capital requirements and employing contingent capital instruments. She will focus on the incentives of bank managers and the roles of investors throughout the capital structure, particularly for large U.S. banking organizations, over credit cycles. Each potential reform will be discussed in a financial stability context.
